- Absentee ballots will be mailed on Monday, October 5, 2020.
- Returned Absentee Ballots must have a postmark on or before the deadline of Monday, November 2, 2020.
- You or your designee may deliver your ballot to the Auditor's Office at 513 N Main St., 2<sup>nd</sup> Floor before the polls close on Election Day by <u>9 p.m.</u>.
- Please be sure to sign your own name on the absentee request form. <u>It is forgery</u> for anyone other than the voter to sign the absentee ballot request form. This includes all family members.
- <u>It is illegal</u> for a Power of Attorney to sign the absentee ballot request form as a Power of Attorney.
